A) The Offline / Online classes (Blended Mode) for V Sem B.Sc., III Sem B.Sc. and M.Sc. III Sem in HHA will be commencing from **14/09/2021**

The students opting for Offline / Online classes need to submit the consent forms filled up by their parents on or before **5/9/2021**. The consent form is available on Institute website.

IMPORTANT INSTRUCTIONS FOR STUDENTS

- 1) As directed by Government of Karnataka, students are requested to get atleast 1st dose of vaccination before reporting for offline classes along with a copy of the vaccination certificate.
- 2) Students need to carry a negative RTPCR Report (done 72 hours prior to reporting at the Institute).
- 3) Thermal scanning will be done at the entry point and only asymptomatic students will be allowed inside the campus.
- 4) Use of a face covers / masks is mandatory inside the college campus.
- 5) Physical distancing of at least 6 feet to be followed as far as possible.
- 6) Students should report to the respective departments as per the time table.
- 7) Self-monitoring of health by all students and reporting any illness at the earliest to be intimated to the Class Teachers
- 8) Students are not allowed to stay in Campus after their class timings and are not permitted to gather in common areas
- 9) Hostel facility will not be provided for both M.Sc. and B.Sc. students
